or the property of others and injury to me or to others, including loss of limb or life, wherever occurring.

I hereby release, waive, forever discharge, covenant not to sue and agree to hold harmless the Institution, including its governing board,
officers, agents, and employees for any injury, loss, damage to personal property, or other source of liability arising from riding in a
personal vehicle to the Activity, wherever same might occur, including but not limited to, medical bills, court costs and attorney's fees, any
damage to my property or the property of others and injury to me or to others, including loss of limb or life, wherever occurring, except in
the Tennessee Division of Claims and/or Claims Commission as provided pursuant to Tenn. Code Ann. §9-8-101 *et seq.*

It is my express intent that this release and hold harmless agreement shall bind the members of my family and my spouse, if I have one, if I
am alive, and my estate, heirs, administrators, personal representatives, or assigns, if I am deceased, and shall be deemed as a release,
waiver, discharge and covenant not to sue except as described herein.

I further agree to save and hold harmless, indemnify and defend the Institution from any claim including, but not limited to, by my spouse,
family, heirs, estate, or other third party representative(s), related to the Activity and/or transport in a personal vehicle, driven by another
individual in connection with the Activity.

I further agree that this Agreement shall be construed in accordance with the laws of the State of Tennessee. If any term or provision of
this agreement shall be held illegal, unenforceable or in conflict with any law governing this Agreement, the remaining provisions shall
remain in full force and effect.
