A Cultural Shift

In the fall of 2021, Chattanooga State embarked on a transformative journey to enhance our students' educational experience and elevate our campus culture. The most significant shift was the transition of over half of our courses to a 7-week format, a decision informed by research and data demonstrating the increased success rate for students taking fewer courses concurrently in shorter time frames. This trend was evident not only in national data but also within our own Chattanooga State courses that had already adopted the 7-week format.



Our dedication to fostering student success drove the implementation of additional support measures such as tutoring, early alerts, and relational advising. These initiatives were built upon the foundation of our new, shortened class structure.

However, even more profound changes were occurring within our campus culture. A diverse team of faculty and staff diligently worked together over several weeks to redefine our purpose, mission, and values. These intensive workshops allowed us to assess our strengths, identify areas for improvement, and understand our role within the Chattanooga community and our responsibility to cultivate the workforce that powers our economy.

Our newly established purpose statement serves as a beacon, illuminating our path forward and defining our "why" to support and empower everyone in our community to learn without limits. Meanwhile, our values statements embody who we aspire to be and will inform our decision-making processes. Together, these guiding principles will underpin our strategic plan update.

To ensure we were truly embracing our purpose and values, the College conducted focus groups to assess our performance and identify areas of opportunity. This collaborative effort aimed to evolve Chattanooga State into an institution led by "truly human leadership."

With the invaluable input from the focus groups, we revised our mission statement and developed a strategic plan framework centered around three key areas: holistic student support, teaching excellence, and program innovation. These objectives are reinforced by our commitment to an inclusive organizational culture and financial stewardship.





Chattanooga State Student Named TN Student of the Year

Chattanooga State's Zennia Nesmith was named the Tennessee Community College Student of the Year during the College System of Tennessee's 4th annual Statewide Outstanding Achievement Awards (SOAR) ceremony held March 30, 2022, in Nashville.

Zennia's personal story is one of resilience and hard work. Although she did not graduate from high school, a year after her daughter was born, Zennia completed her GED and made a decent living working. Twenty years later she enrolled at ChattState at no cost thanks to the Tennessee Reconnect scholarship, a program her husband had already completed.

Zennia maintained a 4.0 GPA, joined the Honors program, was awarded the Chattanooga State Foundation Beacon Scholarship, and earned the highly competitive Dream Scholar program where she was one of eight community college students chosen nationwide.

"Zenniais an inspiration to the faculty, staff and students at Chattanooga State," said Chattanooga State President, Rebecca Ashford. "She overcame many obstacles to enroll in college, and she is determined to succeed. She is incredibly deserving of this recognition. We at the College are so very proud of her."

Chattanooga State and CARTA Announce Rideshare Agreement

Chattanooga State and the Chattanooga Area Regional Transportation Authority (CARTA) reached a universal rideshare agreement that allows all Chattanooga State students, faculty, and staff to ride CARTA for free with a valid ChattState ID. The agreement is for all routes, not just the ChattState/Amnicola Route.

"As Chattanooga State resumed in-person instruction, addressing transportation barriers will ensure a smooth transition from virtual learning to face-to-face instruction," stated Dr. Amanda Bennett, vice president for Student Affairs. "Providing a safe and fare-free transportation option helps to remove a barrier that may otherwise prevent students from completing their education."

American Association Community Colleges (AACC) estimates that the average full-time community college student spends \$1,760 per year on transportation identifies the cost transportation or access to reliable significant transportation barriers to student retention and success.



Chattanooga State's Johnson & Hammond Earn CMBE Status

Chattanooga State's Massage Therapy program faculty members Renee Johnson and Tiffany Hammond recently earned Certified Massage and Body Educator (CMBE) status from the Alliance for Massage Therapy Education (AFMTE). Ms. Johnson is the senior instructor and program director for the program and Ms. Hammond serves as an associate instructor.

CMBE certification is for a period of three years, renewable upon completion of nine continuing education hours concentrated in the areas of teaching and learning.

"I feel honored to be one of the few instructors to become a Certified Massage and Bodywork Educator (CMBE) through AFMTE not only in our state but in the nation," said Ms. Johnson. "Going through their rigorous process was very validating in that I passed a very strict standards test, and that we are providing a quality education in a CTE (Career and Technical Education) venue."

Ms. Hammond agreed that achieving this certification will elevate their TCAT program. "This certification will show that we are willing to go the extra mile for our students and continually learn new aspects of teaching to bring to the program," she stated.



SkillsUSA Medals Awarded to 18 Chattanooga State TCAT Students

Thirty statewide gold medal winners representing the Tennessee College of Applied Technology (TCAT) at Chattanooga State returned with 18 medals from the 2022 National Skills USA competition in Atlanta. Chattanooga TCAT students were among the 6,600 competitors representing the best of 330,000 student members.

Chattanooga State's TCAT Dean Jessica Green says that the students who enroll in the TCAT division are a special group of students. "They have chosen to enroll in a full-time program to pursue an education with a particular job in mind, and most do this while caring for their families and working fulltime," noted Ms. Green. "What they accomplish is impressive and to take on the additional work required for SkillsUSA is even more impressive. We are proud of each and every one of the students that participated in SkillsUSA and feel that the national recognition of some of them is a reflection of the great education and training our students are getting at Chattanooga State."



Chattanooga State's Registered Nursing Program Named Best in Tennessee

Nursing Schools Almanac ranks student performance on Council National Licensure Examination for Registered Nurses (NCLEX-RN). This is the exam that aspiring registered nurses in the U.S must pass before they commence practice. "We use several years of data to calculate each school's NCLEX pass rate among first-time test-takers, and then we rank the schools accordingly," said Christopher McMillen, editor in chief, Nursing Schools Almanac, in his congratulatory letter.

"Being recognized as the #1 Associate Degree Nursing Program in the State of Tennessee is truly an honor," remarked Dr. Martina Harris, assistant dean and nursing program director, Nursing & Allied Health division. "I am proud of our outstanding reputation and as a program we remain committed to preparing quality nursing graduates to provide safe, competent care."

Nationwide, there are 1,046 nursing schools that offer an Associate Degree in Nursing (ADN), also known as Associate of Applied Science (AAS) degrees, such as what Chattanooga State Community College offers.



7-Week Classes—Stay Focused. Stay Motivated. Stay on Track.

While Chattanooga State began offering two 7-week terms during the spring 2021 semester, during the fall 2022 semester approximately 50% of classes adopted the new format. The 7-week format allows the student to take the same number of credit hours as they would normally take during a regular 15-week semester, only they are taking fewer at a time.



The 7-week format splits in half the traditional 15-week semester. Students can take 2-to-3 courses during the first 7-week term, and 2-to-3 courses during the second 7-week term. For instance, if you normally take 5 classes in a 15-week semester, the first 7 weeks you might take 3 classes and in the second 7 weeks you might take 2 classes.

It doesn't matter how you break the data down: gender, race, income, or age. Here at ChattState we have seen an increase of 10–15% of students are more likely to finish classes during the 7-week session than they are in a 15-week session. This better completion rate can be attributed to being able to stay focused because of fewer classes, stay motivated because of a shorter term, and stay on track because of fewer classes to plan around.

Global Center for Digital Innovation Opens at ChattState

The partnership between Chattanooga State Community College, Hamilton County Schools, the STEM School, and the Public Education Foundation came full circle on October 20 as representatives from each entity, including public officials, community members, and invited guests gathered to witness the grand opening of the Global Center for Digital Innovation (GCDI). The completed Global Center for Digital Innovation is where ideation, creation, and fabrication collide with entrepreneurship in the world's first K-14 teaching and learning fabrication lab.

The GCDI, a 15,000 sq. ft. second floor addition to Chattanooga State's Center for Engineering, Technology, Arts and Sciences (CETAS) features a clean space lab with 3D printers, laser cutters, computers, and electronics. A second lab workshop will include saws, CNC routers, CNC mills, and other tools to allow students to produce prototypes. There will also be a collaboration and entrepreneurship center for large and small groups to work together on projects to plan and consider marketing concepts.



Chattanooga State Announces 2021 Excellence in Philanthropy Awards






