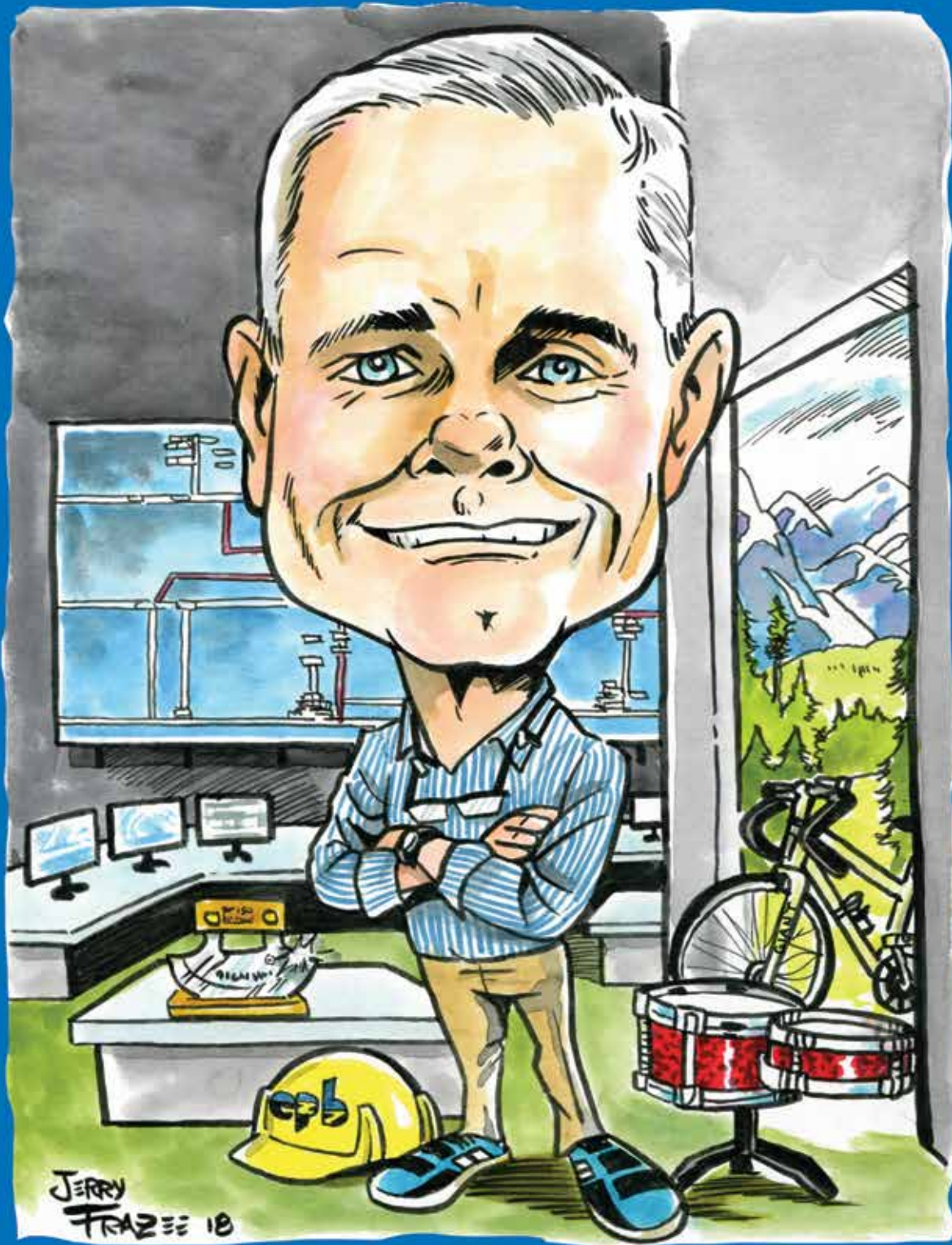

David Wade

A native of Chattanooga, David Wade was born in 1958. For his parents Buddy and Dorothy, David was the mischievous middle child in a family that also included his older sister, Sherry, and his younger brother, Jeff. After graduating from East Ridge High School, David started at University of Tennessee at Chattanooga (UTC), but his first attempt at college ended after one semester in what some might have considered a “failure.” However, David continues to think of this experience as a life lesson in personal accountability. Although this was the last time David would have the chance to be a full-time student, his education was just beginning.

He got a day job, and began attending Chattanooga State at night to study Industrial Electricity. Upon graduation, David landed a job he enjoyed as a maintenance electrician at a local steel plant. In 1983, he joined EPB as a Line Helper, an entry-level job that involved digging holes and assisting linemen. At this point in his career, his primary goal was to become a lineman himself someday. After eight years, he started the Lineman Apprentice Program and learned to climb poles. Later, an opportunity opened in EPB’s Engineering area, and David returned to Chattanooga State to pursue his Associate of Science degree.

Like his previous stint at Chattanooga State, he continued to work full-time while going to school at night. As a result, it took him several years to graduate. Then, he continued his education by returning to UTC, where he eventually graduated with a Bachelor of Science degree in Engineering.

While completing his education, David continued to progress in his career at EPB holding a number of positions that eventually included Vice President of the Electric Power System and Chief Operating Officer. In 2016, the EPB Board of Directors unanimously appointed David as President and CEO. Along the way, he gained experience while working in several areas and developed his leadership skills.

Among his many notable accomplishments, David led EPB’s effort to design and build Chattanooga’s community-wide fiber optics network, which also served as the communications backbone for constructing the nation’s most automated electric power distribution system. Together, these separate but closely related efforts served as the platform for making Chattanooga the “Gig City” with the world’s fastest internet and America’s most advanced smart grid.

Although David rightly attributes these successes to the teamwork and contributions of hundreds of people, his vision, technical expertise, and leadership were essential to completing this ambitious undertaking which thrust Chattanooga into the national and international spotlight.

When David joined EPB, he did not envision a future that would include so many opportunities. He feels blessed to have spent his career working for an organization driven by a mission to “improve the quality of life in our community.”



He frequently expresses his appreciation for being able to learn from and lead the amazing group of individuals at EPB.

David currently serves as Chairman of the Board for the Tennessee Valley Public Power Association (TVPPA). He also serves on the U.S. Department of Energy's Electricity Advisory Board. In addition, he is a member of the Board of Directors for Habitat for Humanity, the Enterprise Center, and River City Company, as well as a member of the Advisory Board for the UTC College of Engineering and Computer Science.

For David, his family plays a central role in his life. He and his wife, Sherry, have been married 39 years and have two sons, Jeremy and Justin, and one daughter, Amanda. He and Sherry also have two granddaughters, Kenzie and Lilly. Outside of work, David can often be found riding or running with Justin or Amanda, or in the wood shop building furniture with Jeremy. As in his professional life, David also enjoys big challenges in his free time. In fact, he has completed three Ironman and Alaskaman races in the last four years.

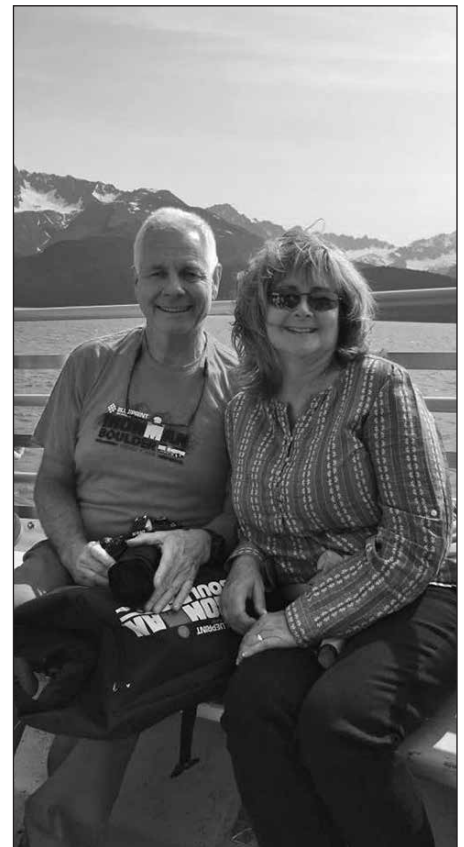
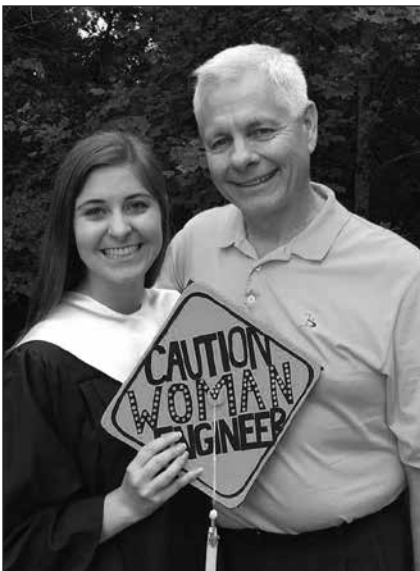

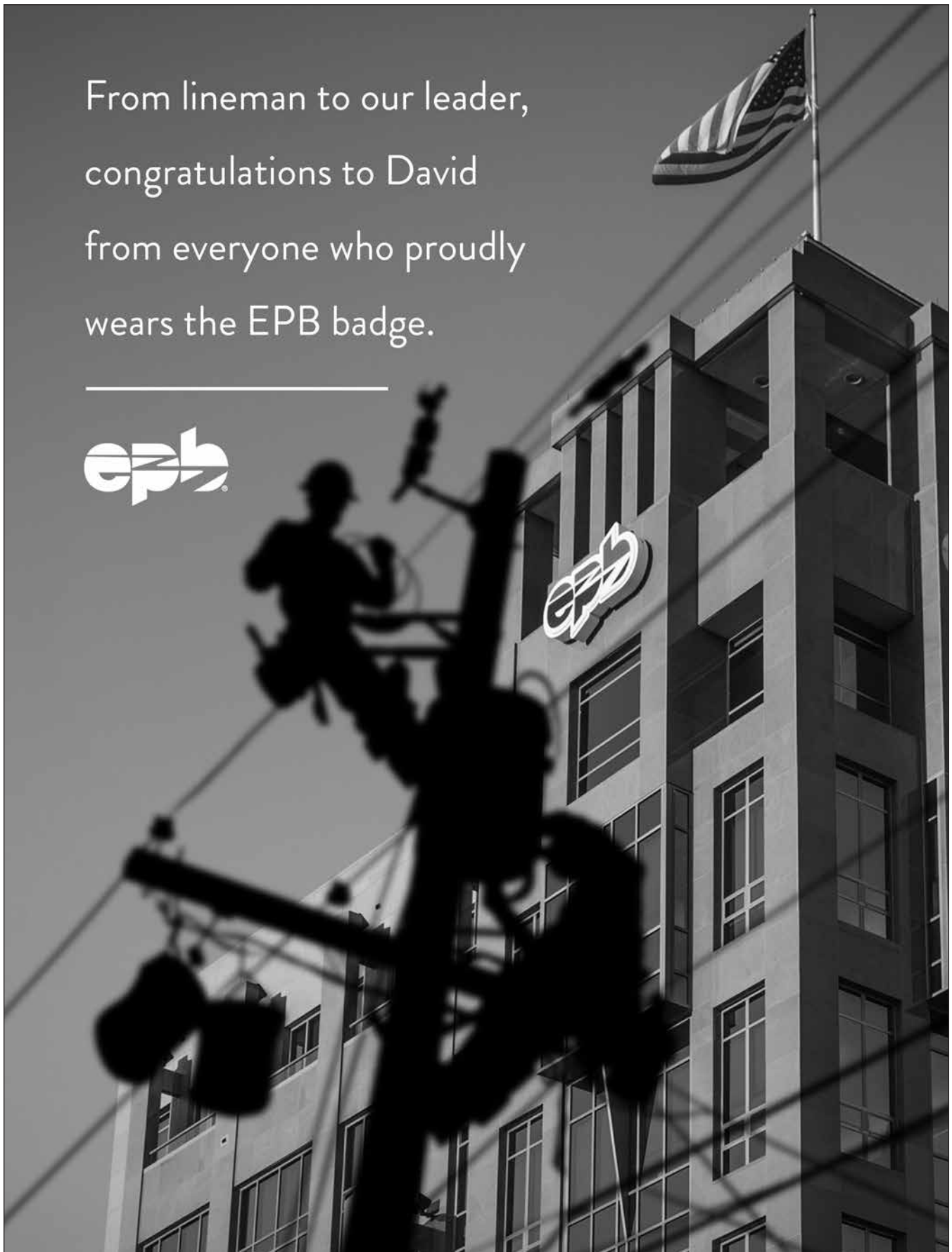

Richard serves on the Board of Directors of several local entities where his expertise has been put to good use. He is also active in several local charities and always rises to the call when approached.

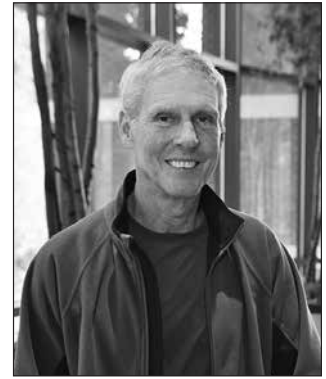
