




LEONARD FANT

Willis Leonard Fant was born to Mary Ellen and Silas Thomas Fant on November 8, 1933. The youngest of nine children, his early years were spent in a three-room house on a farm in Hope, Arkansas. His father was a sharecropper, and from as early as Leonard can remember, he knew how to work hard. Each day, he milked cows before he walked a mile to a one-room school; later he plowed fields and picked cotton.

When Leonard was sixteen he left the "fields of cotton" to move with his parents to Chattanooga to be closer to his older brothers and sisters who were working and attending the Seventh-Day Adventist School in Collegedale.

Leonard graduated from Red Bank High School where he played on the varsity basketball team and was inducted into the Hall of Fame in 2005. His first job in Tennessee was washing Greyhound buses in Knoxville where he became a UT Volunteer fan. His visit in 1951 with his older sister "Maggie" Messick, a Nurse at Campbell's Clinic,



started his career in the medical field washing glassware in the Campbell's Clinic Lab.

He graduated from the University of Chattanooga (today UTC) and earned his B.A. degree along with his medical technology degree from Erlanger School of Medical Technology. He went on to earn his Master's Degree in hospital administration from Georgia State University in Atlanta, all while continuing to work. For a time he was working at Erlanger in the mornings, Children's in the afternoons, and Tri-County at night.

While working as a technician at Tri-County, he met a lovely young lady by the name of Bobbie June Britton who was also a hospital employee. Some 14 months after their first date, they were married on March 25, 1956.

Leonard continued to wear many hats during the late '60s and early '70s. During this time, he served for nine years in the National Guard and was honorably discharged as a First Sergeant. He also served three terms as Mayor of Fort Oglethorpe, and assumed the duties of city judge trying approximately 8,000 cases.

He became Assistant Administrator of Erlanger and Children's Hospital as well as assuming leadership with the Alton Park Health Center. In the 1980s he accepted the position of C.E.O. of Hutcheson Medical Center. Then in the early '90s he was once again urged to take the helm of a fourth medical institution becoming the C.E.O. of North Park Hospital. Leonard, one of the original founders of Blood Assurance of Chattanooga in 1972, returned to them in 1997 as President and CEO. He retired from there in 2008 after 11 years.

Currently Chairman of the Northwest Georgia Bank Foundation Board of Directors, and the Chair of Hutcheson Health Foundation, Leonard continues to be an active volunteer leader in many organizations.

Leonard is always ready to take on a challenge. Be it business, fundraising, golf, or cycling, his enthusiasm is contagious. He is a tireless advocate for good causes and has a proven track record for success and integrity. He does it all with the urgency, competence and spirit of fun that are his trademarks.

For the past 64 years, Leonard Fant has called Chattanooga and North Georgia "home," and he has enriched the lives of this community and all who dwell within it. Leonard and his wife Bobbie have three children, Lynn Fant-Burke and husband Larry, Britt Fant and wife Ruth, and Drenda Fant Paulson and husband Mike. They have five grandchildren: Lindsay Paulson McDaniel and husband Travis, Matthew Paulson, Kelly Paulson; Garrett Fant and Colbie Fant.

COMMUNITY HIGHLIGHTS

Famous for his bicycle fundraising skills, he has raised nearly \$100,000 with rides to benefit such charities as the MS Society and American Diabetes Association.

A Chattanooga State Foundation Board member since 2005, Leonard was Campaign Co-Chair of Chattanooga State's most recent health science capital campaign ending in 2008. Under his leadership, the campaign goal of \$3,000,000 was exceeded by more than \$700,000. More recently, Leonard served as ChattState's event Chair for the new mission-centered benefit "Dinner of Firsts" for its inaugural year in 2012 and again in 2013.

Leonard was among the original organizers of the Friends of the Park in 1986, when the group was founded to help plan the 100th anniversary of the Chickamauga and Chattanooga National Military Park.

Leonard has fifty-five plus years of service to the Kiwanis. He has been President of the Fort Oglethorpe, GA club twice, was Fort Oglethorpe's Kiwanian of the year in 1973, and received the Tablet of Honor award from the Kiwanis International Foundation. He also received the Distinguished Service Award of Kiwanis International in 1992 and 1993.

Leonard has served as Chairman of many organizations and events including: Urban League, American Lung Association, Tennessee Hospital Association, Heart Ball, March of Dimes Gala, Hutcheson Health Foundation Board, and Catoosa Performing Arts Foundation.

James Rogers

He's as patriotic as old glory. The lyrics of his songs strike a powerful longing in our hearts for the days when things were simpler and all Americans stood strong, proud and together. His music sets us free to dream, knowing that dreams can come true as long as you believe. We are able to soar with his music much like his beloved eagles now soar above our great country. This is James Rogers, entertainer extraordinaire.

James was born in Chattanooga, Tennessee and attended school at East Lake Elementary where he was chosen to represent his class in a talent show. For the first time, James Rogers met his public.

In 1958, the Rogers family moved across the state line to Fort Oglethorpe, Georgia, where James' mother still lives. His first guitar arrived on Christmas morning when James was 11. A graduate of Lakeview High School in 1967, he was chosen for many honors, including Most Popular and Most Handsome.

In 1969, after receiving his associate of arts degree from Dalton Junior College in Georgia, James entered the University of Tennessee at Chattanooga with his sights set on becoming a lawyer. He also ioined the National Guard.

His singing career began in 1972 at the Light Fantastic on Brainerd Road, and he has sung for a living ever since. He began singing at The Station House at the Chattanooga Choo Choo in 1973 and from 1975-1983, Rogers toured the country opening for Alabama, Dolly Parton and Ricky Skaggs.

During his long tenure at the Station House, James met his wife, Debbie. In the summer of 1974, James received his BA from the University of Tennessee at Chattanooga. On December 22, 1974 James and Debbie were married in the Crystal Room of the Choo Choo. They now have two grown children, Heather and Justin.

In 1993, he partnered with Dollywood Company to open the Music Mansion where he was the featured entertainer through 1998. James Roger's song, "I Guard America" was adopted in 1999 as the official song of the National Guard.

In 2011, Rogers retired from performing regularly at Dollywood, and today enjoys performing at benefit concerts at various places around the country.



Cluade Ramsey

Former Hamilton County Mayor Claude Ramsey is a Hamilton County native who was a strawberry farmer when he first entered politics in 1972, serving two terms as a state representative. He was a County Commissioner briefly before being elected Assessor of Property, and served fourteen years in that office, before running for County Executive (now County Mayor) in 1994. Ramsey was elected to a fifth four-year term in August 2010 before he resigned to serve as a Chief of Staff and Deputy to Tennessee Governor Bill Haslam.

Claude Ramsey has served on the boards of numerous agencies, including the Orange Grove Center, Chattanooga Neighborhood Enterprises, the RiverCity Company, and United Way. He served on the Board of Trustees at Erlanger Health System and was Chairman of the Board of Associates at Chattanooga State Community College.

Throughout his career, Claude Ramsey has succeeded in his efforts through hard work and persistent pursuit of his goals. He was named "Chattanooga Area Manager of the Year" in 2003. The award is presented annually to an executive whose management skills have profoundly influenced the outstanding performance of a key element of American business, industry, government, or nonprofit activity. He was also named "Outstanding Legislator" by the Southern Health Associates.

His diligence in tackling issues that affect quality of life have become well known across the state. Initiatives such as Read 20, Step ONE, and Hamilton Shines made headway in addressing literacy, obesity, and public littering. He has played a key role in the creation of the Tennessee Riverpark, a facility considered by many as one of the nation's top greenway systems.




